### Curriculum Vitae

Principal subjects dealt with have been international and European law, international human rights law and protection at international level and regional level, minorities’ rights.

She holds a Postgraduate Certificate in *International Protection of Human Rights* (University of Rome “La Sapienza”). The principal subjects dealt with have been jurisdictional and non-jurisdictional protection of human rights; international protection of refugees, minorities, persons with disabilities and children; International Criminal Courts; development cooperation strategies, human rights project management.

She holds a Master’s Degree in *International Relations (Peace Studies, Democratization and Conflict Transformation)*, University of Roma Tre). The principal subjects dealt with have been International Jurisdictions, European politics for Security and Development Cooperation, Democratization Processes, Conflict Transformation Theories and Techniques, International Protection of Human Rights in Peace and Democratization Processes.
